VISITOR	SEVERE (6-10)	Neck and spine injuries, severe head injuries, crushing, face and eye damage, severe cuts/lacerations	Emergency services to attend at property.	Visitor to phone 111 immediately. Address is 706 Knobby Range Road, Roxburgh. GPS -45.449925, 169.355335.	
				Visitor also contact KRP via cellphone Dinah 021 041 2913 or Jeremy 022 601 7721. KRP to meet ambulance at house and guide them to visitor location OR KRP to carry Emergency Locator Beacon to the incident site in the case of a helicopter extraction.	
	MODERATE (3-5)	Broken limbs, fractures, concussion.	Transport injured person to their vehicle.	Visitors also contact KRP via cellphone Dinah 021 041 2913 or Jeremy 022 601 7721. KRP to provide transport from incident site to visitor vehicle using ute, side-by-side or similar vehicle appropriate to the terrain.	
			Transport injured person to medical service	Visitor to arrange care with their own medical service, or Roxburgh Medical Centre 03 4468 200. Visitors too transport injured person in their own vehicles.	
	MILD (1-2)	Moderate cuts/lacerations, sprains, sunburn, insect bites/stings	Visitors to arrange medical care in their own time.		
HORSE	SEVERE	Broken bones, deep penetrating injuries, severe hoof or leg damage	Horse to be euthanised (decision made by owner).	KRP to have a suitable firearm available. Operator to hold current NZ Firearms licence. KRP to dispose of carcass, or visitor can arrange removal.	
				OR owner arranges for vet to visit to anaesthetise or treat horse (at owner's expense). Visitor is responsible for transport of horse away from the property.	
		MODERATE	Severe cuts/lacerations, eye injuries, hoof or leg damage	Vet to attend at property.	Visitor to lead horse back to their vehicle.
					Visitor makes arrangements with their own vet to visit. If owner's vet unavailable, Becci Ireland may be able to provide emergency care, phone XXXX
				Horse to remain at property until it is able to be transported away.	KRP to provide suitable yard for horse to be kept in. Yard fees may apply after first seven days.
				Horse to be transported home.	Visitor to arrange transport for horse back to home.
	MILD	Minor cuts/lacerations	Horse to be transported home.	Visitor to lead horse back to their vehicle.	
				Visitor to arrange transport for horse back to home.	
				All other decisions regarding veterinary care to be made by the visitor once the horse is home.
